With its first issue published in August 2020, the Global Academic Nursing Journal comes up with a different proposal for the scientific community. Based on its scope focused on Health Sciences, more specifically on Nursing and Medicine, the year 2021 ends with 212 scientific articles published and an international scientific event, the I Global International Conference on Health: assistance, management, teaching and research to fulfill its mission and values, which include: transparency, ethics, continuous improvement, respect for researchers and Science and the path hand in hand between Science, Research and Education.

Among the studies published until December 2021, the study¹ stands out with the highest number of views, totaling 3,020, entitled "Aesthetic Nursing: advances, dilemmas and perspectives". A relevant fact to be analyzed is that, even though it is the study with the highest number of views and downloads, it is not the most cited study, thus revealing the gap that exists, and that needs to be filled, in the publication of scientific evidence on the Aesthetic Nursing.

The second most viewed study² has 1,275 views and downloads, as well as being the fifth most cited article, entitled "Relationship between deep vein thrombosis and its risk factors in the female population". This is an original study that may have had its relevance increased by the harm that COVID-19 caused in women, given its clinical presentations and complications in the female population.

The third most viewed study³ has 950 views and downloads, in addition to being the fourth most cited article, entitled "Use of personal protection equipment during COVID-19". With its publication in August 2020, it brought the discussion about the scarcity and need for personal protective equipment for health professionals at the height of the crisis that the pandemic brought to hospitals and healthcare units in the country.

As for the citations, the most cited manuscript⁴, entitled "Consumption of psychoactive drugs in the sexual context among gay men as a risk factor for HIV/AIDS transmission", is a review that seeks to analyze the impacts of sexual practice with drug use psychoactive effects, on the physical and mental health of its supporters, as well as their impacts on public health. Their findings point to the need to implement public policies focused on promoting support and reducing harm to this population.



As the second most cited, we have the article⁵ entitled "Reflections on the COVID-19 pandemic and actions of permanent nursing education in a hospital", which deals with the role of the permanent committee in a tertiary hospital in Ceará, on the care of patients with COVID -19. In addition to the need for quick action and implementation of education strategies needed in the pandemic context, the article points to the need for deeper discussions about the precariousness of employment relationships and the appreciation of the nursing team, which is so necessary and active in the pandemic.

The third most cited study⁶, "Contributions of monitoring in Nursing Fundamentals II in the academic training of nursing students: experience report", points out the importance of student performance in monitoring, with the possibility of acting in teaching and greater access of academics to monitor, which gives better quality to training.

The fourth most cited study³, "Use of personal protective equipment during COVID-19", points to one of the most difficult moments today and the impact of the COVID-19 pandemic on society and on the lives of healthcare teams. It deals with personal protective equipment (PPE), what the equipment is, how to use it and its effectiveness and safety.

Furthermore, the Global Academic Nursing Journal had a positive impact on the academic world, with significant studies for the renewal and updating of scientific knowledge, both in practice and in theory. Renewing, with each edition, its commitment to education and health.

By carrying out a brief reflection on this year and a half of the Global Academic Nursing Journal, it is possible to see that the axes of assistance, management, teaching, and research permeated the most viewed and cited studies. In this sense, it is understood that this journal, despite the short circulation time, manages to support reflections on health care, based on the most recent scientific evidence, thus maintaining the commitment to Science, Research and Education.
